KEYNOTE SPEAKER LUNCHEON

HCIC is thrilled to welcome Chipper Wichman, President of the National Tropical Botanical Garden.

For his entire adult life, Chipper has worked to preserve the precious natural and cultural resources of Hawai'i where he was born and raised. He began work at the National Tropical Botanical Garden (NTBG) in 1976 conducting botanical surveys of Limahuli valley and the Nā Pali coast where he discovered many new species of plants and helped to pioneer methods of rappelling down cliffs to hand pollinate the species threatened with extinction. Over the past 43 years, Chipper has held various leadership positions at the NTBG including director of two of their five gardens before being promoted in 2003 to Chief Executive Officer. Currently, Chipper holds the position of President with a focus in external relations and international collaborations.
